



THE COUNTRYSIDE ACCESS (EXCLUSION OR RESTRICTION OF ACCESS) (WALES) REGULATIONS 2003.

DRAFT DIRECTION TO EXCLUDE THE RIGHT OF ACCESS.

This **draft** direction only excludes or restricts the right of access given by section 2 of the Countryside & Rights of Way Act 2000. It does not affect other rights that may exist on the land, such as public rights of way. Also, it does not remove the need for any other consent or permission that may be required for operations on the land. For example, it does not replace the need to give notice to Natural Resources Wales about proposed operations on SSSIs, or to obtain a felling licence for the felling of trees.

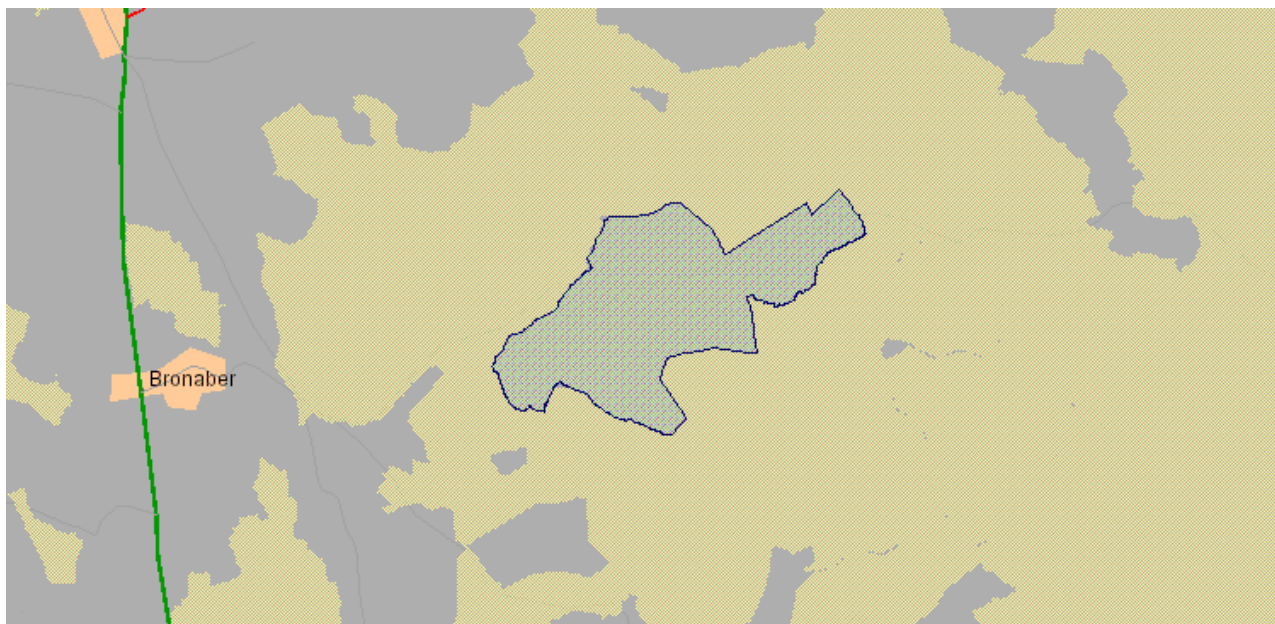
