

## LIFE Natura 2000 Programme for Wales

August 2015

The LIFE Natura 2000 Programme is producing a strategic plan for the management and restoration of all Special Areas of Conservation (SACs) and Special Protection Areas (SPAs) in Wales, both on land and at sea, for the period 2014 to 2020 and beyond. The project is run by Natural Resources Wales (NRW) and is financially supported by the EU LIFE+ fund.

### Thematic Action Plans

Draft Thematic Action Plans are now available to partner organisations wishing to provide input and feedback. These outline proposed strategic actions to address major issues and risks affecting Natura 2000 sites, habitats and species across the network in Wales. The draft actions have been generated from a series of issue specific workshops and meetings with NRW and Welsh Government specialists and other representatives, and we are now seeking a wide as possible engagement.

### Prioritised Improvement Plans (PIPs)

PIPs for every Special Area of Conservation and Special Protection Area in Wales have now been drawn up, based on information from NRW site officers with input from organisations which are responsible for delivering actions or own N2K land, and European Marine Site Officers. Many thanks to all who contributed. We are now in the process of incorporating feedback and finalising costings.

We are able to provide access to the PIPs for other organisations with specific interests that wish to comment. However, PIPs will not be published online since many contain sensitive information. Please contact us on the email below, stating which sites are of interest.

The PIPs are live documents which can be updated by site officers at any time, so the process of incorporating feedback from partners can continue beyond the duration of the LIFE N2K Programme.

## Wales Biodiversity Partnership Conference

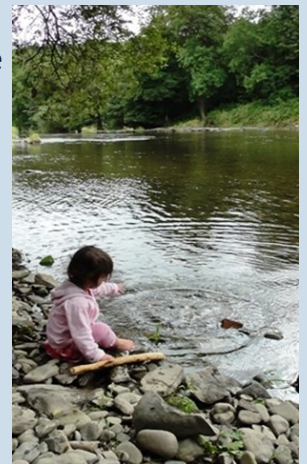

## External Competitive funding

Natural Resources Wales has announced £1.2 million of funding to invest over the next two years for projects to improve the environment across Wales. The money will be available for third sector organisations and local authorities for projects on sites designated as Special Protection Areas and Special Areas of Conservation.

It can be used to match-fund projects that tackle key issues affecting these sites, focusing on five key areas, invasive species, habitat fragmentation, inadequate or inappropriate management of woodlands, marine litter, and managing access and recreation to avoid harm.
