Yn unol â darpariaethau adran 48 Deddf Sychu Tir 1991, y mae Corff Adnoddau Naturiol Cymru, ac yntau'n wrdd draenio ar gyfer Ardal Draenio Mewnol Cil-y-coed a Gwynllwg ("yr ardal"), yn hysbys fel a ganlyn:

1. Cyfanswm y dreth ddraenio ar gyfer tir ac adeiladau amaethyddol yn yr ardal ar gyfer y cyfnod o'r 1af o Ebrill 2017 hyd yr 31ain o Fawrth 2018 yw £0.061 yn y bunt.
2. Cyfanswm y treuliau sydd i'w codi trwy drethi draenio yw £28,677.00 a'r cyfanswm sydd i'w godi trwy ardollau arbennig yw £970,326.00.
3. Pennwyd y dreth ddraenio ar 26fed Ionawr 2017, pan benderfynodd Corff Adnoddau Naturiol Cymru awdurdodi gosod ei sêl gyffredin wrth y dreth.

**SECTION 48 LAND DRAINAGE ACT 1991
NOTICE OF MAKING OF DRAINAGE RATE**

In accordance with the provisions of section 48 of the Land Drainage Act 1991 the Natural Resources Body for Wales as the drainage board for the Caldicot and Wentloog Internal Drainage District ("the district") gives notice as follows:

1. The amount of the drainage rate in respect of agricultural land and buildings within the district for the period 1st April 2017 to 31st March 2018 is £0.061 in the pound.
2. The amount of expenses to be raised by means of drainage rates is £28,677.00 and the amount to be raised by means of special levies is £970,326.00.
3. The drainage rate was made on 26th January 2017 when the Natural Resources Body for Wales resolved to authorise its common seal to be affixed to the rate.
