1. **Gweithio mewn modd cydgyssylltiedig er mwyn darparu blaenoriaethau cynllunio corfforaethol gan gyfrannu at Ddeddf yr Amgylchedd a Deddf Llesiant Cenedlaethau'r Dyfodol.**
2. **Gwneud y gorau o'r adnoddau sydd ar gael ar gyfer ein hamgylchedd a'u defnyddio yn y modd mwyaf effeithiol posibl.**
3. **Rhoi gwerth ar y gwaith y mae'n partneriaid yn eu gwneud gyda CNC.**

What is Commissioning?

Here is a standard model of commissioning:-

The process of identifying needs ... and of developing policy directions, service models and the market, to meet those needs in the most appropriate and cost effective way. (Institute of Public Care (IPC))

Collaboration from NRW's point of view



Byddai hyn yn cynnwys:

- Integreiddio canlyniadau cymdeithasol, diwylliannol, amgylcheddol ac economiadd yn unol â Deddf Llesiant Cenedlaethau'r Dyfodol
- Prosesau sy'n cefnogi perthynas gref ar draws pob sector
- Hybu cyfranogiad mewn prosiectau rhwydweithiol yn hytrach na phrosiectau sengl er mwyn cynyddu maint a chynaliadwyedd
- Hybu fframwaith y ddarpariaeth – Cynaliadwyedd

This would involve:-

- Integration of social, cultural, environmental and economic outcomes in line with WFG Act
- Processes that support strong relationships across sectors
- Encouraging participation in networked rather than single organisation projects to gain scale and sustainability
- Facilitating the overall framework of delivery
- Sustainability

Mae'r Byrddau Gwasanaethau Cyhoeddus wedi cael eu sefydlu i gryfhau cydweithio yn y gwasanaethau cymdeithasol ledled Cymru.

The Public Services Boards have been set up strengthen joint working (collaboration) across public services in Wales.

Cydgynhyrchu o safbwynt CNC

Co-production from NRW's point of view



Byddai hyn yn golygu:

- Rhannu llywodraethiant rhwng cydgynhyrchwyr, yn enwedig ar lefel leol/ardal (neu ar lefel y broblem)
- Darganfod asedau a galluoedd sy'n bodoli'n barod. Adnabod pa gymorth sydd eu hangen.
- Symud oddi wrth weithgareddau at ganlyniadau y cytunwyd arnynt ar y cyd gan y rheini sy'n cyfranogi yn y broses.
- Proses sy'n rhoi caniatâd a chyfle cyson i adlewyrchu a gwerthuso ac sy'n ddigon cryf i ailffocysu lle bo hynny'n angenrheidiol.

This would involve:

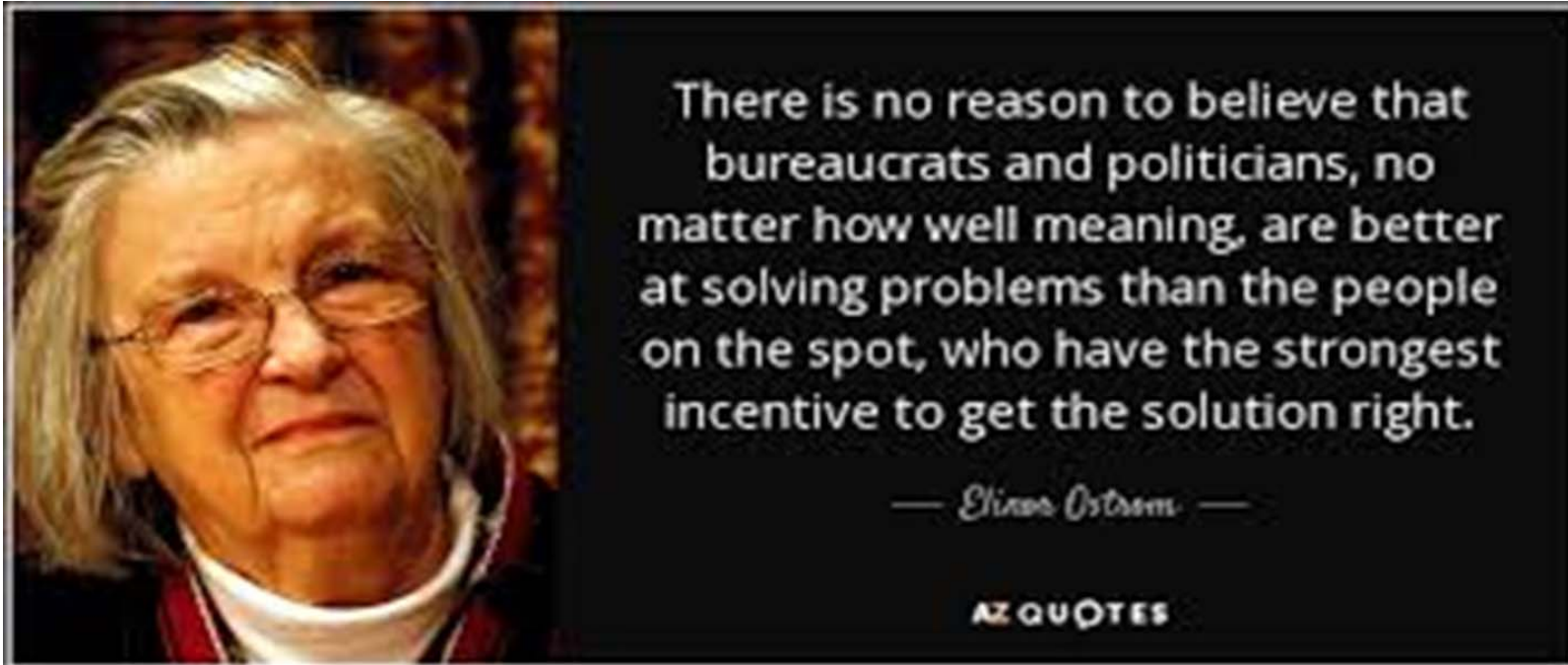
- Shared governance between co-producers, particularly at a local / area level (or at the level of the problem)
- Exploring existing assets and capabilities then identifying what support is needed
- Moving away from activities to outcomes agreed jointly by those participating in the process.
- An process which allows continuous reflection and evaluation, and is flexible enough to refocus where necessary.

Mae Dysgu Cymdeithasol yn fwy na dysgu gan ei fod yn creu dealltwriaeth sy'n arwain at newidiadau mewn ymddygiad a gweithredoedd.

Social Learning for the Integrated Managing (SLIM) and sustainable use of water at catchment scale - An EU-funded, pan-country project) –

Social Learning is more than learning as it creates an understanding that leads to changes in behaviour and actions.

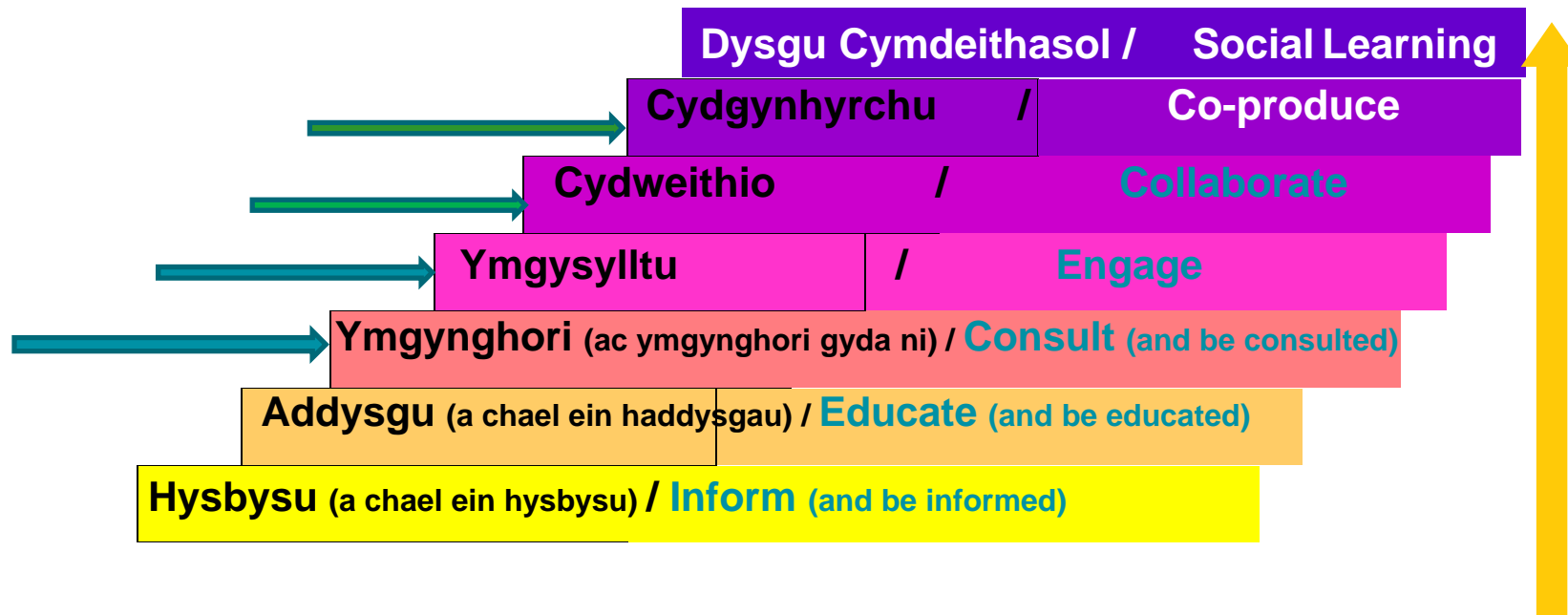

Co-production of Area Statements

- The production of Area Statements will be produced in a co-productive fashion. The process will enable each area to scope what work needs to be done and how to decide what to fund.

Focus on outcomes



- Yn y dyfodol, byddwn yn edrych am *ganlyniadau* a mesuryddion meintiol neu ansoddol i fesur cynnydd.
- Gyda chydgynhyrchu, byddai'r canlyniadau'n cael eu dewis ar y cyd gan y rhai sy'n cydgyfranogi yn y broses.
- In future we would look for *outcomes* and quantitative or qualitative indicators to measure progress.
- With co-production, the outcomes chosen would be selected jointly by those participating in the process.
