#### Issue

- We reported to the last Board meeting the financial position for 2017-18 but it was not yet finalised and that any changes to that position would be reported to the Board in July.
- 2. This report outlines changes to Budgets in Quarter 1 of 2018-19 which were endorsed by Executive Team on 22 May 2018.
- 3. The report also includes results to end of May 2018. It should be noted that we are in the process of updating all budget profiles by end of June so financial performance has been measured in some parts against profiles that require updating.

#### Summary

- 4. The Audit and Risk Assurance Committee (ARAC) have fed back comments on the draft Annual Report and Accounts for 2017-18 at their meeting on 7 June 2018. The audit is scheduled to complete by end of June 2018, the final version of the Report considered by ARAC on 13 July 2018, before being submitted to the Auditor General for Wales. A copy will be circulated to the Board for comment before the next ARAC meeting.
- 5. The latest update on the financial outturn for 2017-18 means that we have £0.3m less funding being carried forward from 2017-18 to 2018-19. That's 0.2% of total expenditure.
- 6. The results of the review into budget performance has been reported to Executive Team and will be reviewed by ARAC on 13 July. An update will be provided to the Board in September.
- 7. Executive Team considered the latest funding position for 2018-19 along with further unfunded proposals. The latest funding position sees our available funding increase from £197.3m to £220.3m. The main reasons for the increase is the improving timber market (£7.3m) and additional Flood capital Grant in Aid (£2.9m).



- 8. At the end of May, our income was £43.8m compared to a budget to date of £43.6m and our expenditure was £23m compared to £23.1m. The profile of expenditure increases significantly from July 2018 onwards. Budget and Project Managers are currently refining profiles.
- 9. Financial Performance in this report is measured against the Revised Budget endorsed by Executive Team in May 2018.

#### **Assessment**

#### **Budget Changes – Quarter 1**

- Changes to Budgets because of the financial position in 2017-18 are summarised in Annex A. Changes to the Budget in Quarter 1 are summarised in Annexes B and C.
- 11. The table below shows how the funding and budget position has changed.

- 12. Our income for 2018-19 has increased from £197.3m to £220.3m. The main funding changes are in Quarter 1 and are in respect of additional timber income forecasted (£7.3m) and Grant in Aid for our Flood Capital Programme (£2.7m). All the funding in Annex A (£5.1m) and some of the funding in Annex B (£1m) is committed to specific programmes or projects. The remainder of the funding is to be allocated.
- 13. Executive Team considered and approved bids totalling £6.7m (Annex C) mainly funded from Grant in Aid and timber sales.
- 14. We already had £3m funding to be allocated within our original budget. In addition, we now have a further £10.2m available for allocation, a total of £13.2m. This is mainly the



impact of timber sales – over £7m. We will be implementing the recommendations from the response to the UKWAS Audit (Land Management Service Plan) and that will use some of that funding (the allocation in this financial year will be assessed in Quarter 2).

15. Executive Team will consider further strategies to utilise this funding in July but also explore the opportunity to carry forward funding to help alleviate financial challenges in 2019-20 and beyond.

#### Financial Performance - May 2018

- 16. Total income was £43.8m, which was £0.2m more than our Revised Budget. Income is performing to profile which includes the additional timber income forecast of £7.3m.
- 17. Expenditure was £0.1m less than budget to date. Budget and Project Managers have to 22 June 2018 to provide updated profiles. Future months show significant increases in budget profile which will be challenging and will need good financial management by budget managers.
- 18. Further detail on year end performance can be found in Annex D.
